Overview of the Urban Forestry Program in each responding state and the roles that the Council and State Coordinator play.

ALABAMA

Alabama Urban Forestry Association is a 501 (3) c non-profit organization.

The business, affairs, and property of the Association are administered by the Board of Directors consisting of at least seven (7) members and no more than fifteen (15) members. Board Members are elected by the members of the association to a maximum of three (3) years for each term. No Board Member will be allowed to serve more than six consecutive years. The officers of the Board of Directors shall be elected by the Board at the first Board meeting following the annual election, and include a President, a President-Elect, a Secretary, and a Treasurer.

The Council serves as a standing advisory committee to the Board and is generally made up of fifteen (15) to thirty-five (35) members. The State Urban Forestry Coordinator and Alabama Cooperative Extension System's Urban Forestry Extension Specialist shall be members of the Council. The Chairman of the Council is a member of the Board of Directors. The Council meets semi-annually with one of the meetings in conjunction with the Annual Convention. Council Members are elected by the membership prior to the Annual Convention, shall serve three (3) year terms, and may serve an unlimited number of terms.

ARKANSAS

The goal of our program is to educate Arkansas communities on how to preserve, promote and protect the Urban Forest through a variety of programs taken to these communities statewide.

Council members participate in AUFC sponsored events such as workshops, our annual conference, Arbor Day activities of the council and in their own communities, helping communities become Tree Cities, helping communities get Arkansas Forestry Commission grants. The Council works according to a Strategic Plan. The Council has four board meetings each year, including a yearly retreat and the aforementioned annual conference.

We have a strong state coordinator, who is greatly involved with the council as an ex-officio member. Our state coordinator works in tandem with the Council to set and reach it's goals.

FLORIDA

The Urban Forestry program is administered by the Florida Division of Forestry in the Forest Management Section. The Urban Forestry program oversees the U&CF grant program which is available to organizations to develop or enhance urban and community forestry programs, handles the Tree City program, and Arbor Day awareness programs.

KENTUCKY

I am in a unique position compared to other councils, as I am the Kentucky Urban Forestry Coordinator. The Kentucky Urban and Community Forestry Council serves as an advisory board to the Kentucky Division of Forestry. The council, in cooperation with the division produces a strategic plan to provide urban forestry program focus and direction. The strategic plan assists in determining the distribution of grant monies, provide urban and community forestry information to communities and organizations across the state, as well as provide overall direction for division program activities.

NORTH CAROLINA

My position, Executive Secretary, works with the Executive Committee on all projects. Almost all of our operating funds come from our grant from the NC Division of Forest Resources. The Executive Committee is comprised of professionals from across the state with interest in advancing urban forestry.

SOUTH CAROLINA

The SCUCFC is a non-profit (501 c 3) group organized to promote and support activities that are designed to foster stewardship of urban and community forests. Its activities are developed to include, but not limited to:

- (a) Expanding the collective knowledge and awareness of the value, management and wise use of trees:
- (b) Facilitating information exchange concerning the management of urban and community forests;
- (c) Encouraging citizens to take an active interest in the care and management of urban and community forests.

The Council serves in an advisory capacity to the State Coordinator of Urban & Community Forestry.

TENNESSEE

Our Council complements the work the state's urban forestry program and extends its ability to reach out and serve communities.

Council Accomplishments for 2003 and 2004

ALABAMA

Arbor Day

AUFA sponsored the State Arbor Day Event in Fairhope, Alabama. Over 100 people attended the day- long event which included workshops, a champion tree award ceremony, luncheon and tree plantings. Acknowledged National Arbor Day Foundation "Trees are Terrific" statewide poster contest winners with a tree planting ceremony on the capital grounds in Montgomery, Alabama. Governor Bob Riley attended. AUFA participated in Arbor Day events around the state in Anniston, Montevallo and Birmingham.

Promoting Urban Forestry at Community Events

AUFA participated in tree plantings at the Marshall Space Flight Center in Huntsville, Urban Forestry event in Florence, Alabama, and presentation to Shelby County Master Gardeners.

Regional Urban Forestry Events & Educational Workshops

AUFA sponsored three regional urban forestry events in Mobile, Montgomery and Huntsville. They included: "Trees for All" - Huntsville Botanical Garden, Huntsville, Alabama; "Montgomery Urban Forestry Tour" Blount Cultural Park, Montgomery. Trolleys were used to show participants Montgomery's champion trees and educate citizens about tree care. "Trees in the Home Landscape" Mobile Botanical Gardens, Mobile.

AUFA held three educational workshops across the state. These events included: "Plant Diseases" Workshop, Prattville, April 18 followed by a forum with more than 20 urban forestry professionals to discuss the "Future of ISA in Alabama"; "ISA Arborist Certification Workshop" Huntsville, July 18; and "Developing and Maintaining Healthy Urban Landscapes" Birmingham, September 30 with Dr. Donald Marx, chief scientist for Plant Health Care, spoke about mycorrhizae, soils and root.

Statewide Radio Public Service Announcement Campaign

AUFA developed and implemented a statewide radio public service announcement (PSA's)) campaign. Two professionally produced PSA's were developed and distributed on CDs. More than 50 targeted radio stations throughout Alabama have received the PSAs.

Annual Convention

The 3 day convention in Opelika, Alabama consisted of educational workshops, outdoor tree worker demonstrations, the AUFA Annual Awards program, urban forestry exhibitors and a golf tournament.

"Trees for Your Home" Urban Forestry Guide

AUFA produced a 4-colorand informative tree care guide for homeowners Copies are distributed at workshops and through extension, municipalities, forestry commission, business partners and the Homebuilders Association of Alabama.

New Partnerships

AUFA has worked with many new organizations during the past year and forged new alliances. Attended conferences: Alabama League of Municipalities, Alabama Recreation and Park Association, Earth Day Events in Birmingham, Samford University, Livable Cities Conference at Birmingham Southern College.

Builder Survey

AUFA conducted a joint survey with the 9,000 members of the Homebuilders Association of Alabama Inc. The survey included internet and written responses.

Alabama Power Foundation "Plant a Tree" Grant Program

In partnership with the Alabama Power Foundation (who provides the funds), AUFA co-sponsors the program by promoting it. In 2003, \$40,000 in tree planting grants was distributed to 75 Alabama communities.
